## Terminology

### Qvarn

Restful HTTP API for querying and storing business data of Vastuu Group Oy.

### Person API

Person API is a restful HTTP service built on top of the the Qvarn API for querying person related data from Vastuu Group Oy's database.

## Authentication and authorization

The API follows Qvarn authentication and authorization. An OAuth 2.0 token with required scope is needed in order to access API endpoints. Token is obtained by making a token request to the authentication endpoint. OAuth 2.0 authentication specifics are not in the scope of this document. OAuth 2.0 **client\_id** and **client\_secret** (essentially username and password) are needed for the authentication. The account corresponding to the **client\_id** needs to have permission to obtain tokens with the required scope. The token is passed in the Authorization HTTP header. Passing the token as a URI query parameter is currently not supported.

## API endpoints

### 1. Tax authority employee report data for a person/employee

**Required scope:** *person\_authority\_reporting\_get*

## Response description

- **qvarn\_id\***: person's unique identifier in Qvarn
- **names\***: list of person's names
  - **full\_name**: person's full name
